Brief History of Federal Urdu University

Baba-e-Urdu Dr. Molvi Abdul Haq established an institution namely Urdu College in 1949 with the same concept of Usmania University and Ali Gardh University especially for teaching all subjects in Urdu. In 1954 the college includes the subjects of sciences in syllabus. In 1972 the Government of Sindh nationalized the all educational Institution including Urdu College, but in 1975 Federal Government took over control of this college because of national language Urdu. A remarkable period was started to promote education in our national language. Afterword the Urdu College was divided into two campuses/colleges one called Urdu Arts College and other one Urdu Science College under the supervision of two separate Board of Governors. A new era was raised and the both colleges started classes of M.A, LLM and M.Sc. The examinations were conducted by Karachi University. There were very good results of both colleges than Karachi University. Preferably most of the students were interested to get admission in these colleges for good results. In 2002 Prof. Dr. Atta-ur-Rehman who was the member of Board of Governors and chairman of Higher Education Commission of Pakistan (HEC) proposed for up gradation of both colleges as University namely Federal Urdu University for Arts, Sciences and Technology (FUUAST). The President General Parvez Musharraf signed a presidential decree and issued a notification ref: CXIX-2002 on 13th November 2002 and both colleges were upgraded and on the other hand the National Assembly also approved the resolution and provides the legal status for all universities of public sector. In 2004, a campus was established in Islamabad, now the University running with three campuses two in Karachi and third one in Islamabad. Needless to say that Federal Urdu University is the only University in Pakistan of national language, a symbol of unity and providing higher education in national language. FUUAST have great privilege to establish campuses anywhere in the country as well as in the abroad. Because of all this remarkable progress the dream of Baba-e-Urdu came true. From the day one the FUUAST objectives are to maintain quality of education and research and facilities to face the new challenges of the new era. The progress and expansion of the University over the short period of time since its inception is remarkable, besides BS (4 Years)/BS (2 Years) programmes, M.Phil/MS and Ph.D programmes are running with full-fledged facilities in Arts, Arabic & Uloome-Islamia (Islamic Learning), Education, Languages, Law, Sciences & Technology along with Engineering, Pharmacy, Business Management, Commerce & Economics faculties.

Preference will be given to recent pass candidates, Open Merit admission based on first come, first served as per eligibility criteria.

(h) Rejection of Application

- *i*. The Vice Chancellor of the University will be competent authority to reject any application without assigning any reason.
- *ii*. The application shall be rejected summarily in case the applicant is found guilty of any suppression of material facts at any stage. The Vice Chancellor can further debar him/her from seeking admission in the University and its affiliated colleges.

(i) Display of Merit List (Test Based Departments)

The merit list for each Department and Programme will be notified on the University Notice Board and will also be made available on the University Website.

(j) Reporting in Person

Applicants whose names appear in the Merit list should personally report for submission of documents at Admission Desk on the date and time specified for reporting according to the schedule as notified by the University on Notice Boards and on its Website.

(k) Submission of Documents At the Time of Admission

Candidate must submit the following documents and the paid fees voucher to the Admission Desk at **the time of admission**.

- a. Secondary School Certificate (S.S.C) or equivalent examination Marks Sheet and Certificate attested copies.
- b. Higher Secondary Certificate or equivalent examination Marks. In case of admission in BS (2 Years) program then submit graduation degree or equivalent after graduation examination marksheet in original to be retained by the University.
- c. Affidavit of non political activities ORIGINAL (On minimum Rs.50/- Stamp paper).
- d. Three passport size photograph.
- e. Pay order of the prescribed fee in favour of Treasurer, Federal Urdu University.

Original documents retained by the University will be returned after the completion or termination of studies by the student at this University.



(l) Important Note

The name of applicants who do not submit required original documents and deposit prescribed fee on the specified scheduled date and time shall stand deleted from the merit list. NO PLEA whatsoever shall be acceptable in case any applicant fails to appear on scheduled date.

(m) University Identity Card

Candidates who are admitted shall be issued University Identity Cards. All students are required to carry and produce original University Identity Cards whenever required.

(n) Cancellation / Withdrawal of Admission

- (i) The Vice Chancellor will be the competent authority to cancel or withdraw admission of any student / candidate.
- (ii) The conduct of each Program is subject to at least number of 25 admissions.
- (iii) If University could not commence classes on the reserved seats due to any reason then fee will be refunded to the student(s) but if student(s) cancelled admission after start of program then fee will not be refunded. This is applicable on all faculties / departments as per academic council decision.

(o) Scholarship Offers

University provides Need Based, Ehsas, Bait-ul-Maal and Al-Kausar scholarships to intelligent and deserving students.

(p) Medium of Instruction

The medium of instruction and examination shall be Urdu and English.

(q) Employment / Simultaneous Enrolment

Undergraduate Programmes in morning are regular fulltime day programmes. No student admitted in any morning programme of this University shall be allowed to engage him/ her in employment or maintain simultaneous enrolment in any other course of studies in the University or other educational institution. Violation of this will lead to cancellation of admission.

(r) Foreign National Candidates

The Federal Urdu University of Arts, Sciences & Technology does not deal with the foreign national candidates its own, however Foreign Nationals whose names are forwarded by the Ministry for Foreign affairs or Ministry for Education of Pakistan are considered for admission if they are eligible.

(s) Mandatory Courses for Foreign Students

Foreign Students are required to successfully complete the following additional courses in their First Year of studies of any undergraduate programme:

- i. English Course of two semester duration.
- ii. Urdu Certificate Course

(t) Promotion Policy in Study

For the promotion policy in study the following criteria will be observed:-

- i. Promotion from first year to third semester second year of study is subject to successful completion of 80% courses of first year.
- ii. Promotion from second year to fifth semester third year is subject to successful completion of all first year and 80% completion of courses of second year.
- iii. Promotion from third year to seventh semester fourth year is subject to the successful completion of all first year and second year and 80% completion of courses of third year.
- iv. For five years degree programs Promotion from fourth year to ninth semester fifth year is subject to the successful completion of all first year, second year, third year and 80% completion of courses of fourth year.

Each candidate shall have to submit an examination form within the due date which shall be notified by the Controller of Examinations.

Attendance

Any candidate who has been a student during the semester will be allowed to appear in Examinations provided his/her aggregate attendance in all courses is at least 75%.

If aggregate attendance is less than 75% then candidate will be allowed to appear in only such course(s) in which his/her attendance is at least 75% during the semester.

Admit Card

- i. Admit card for the examination shall be issued to any candidate who is eligible / allowed to appear in the course as mentioned on his/her card.
- ii. Admit card must be in possession of the candidate while appearing in the examination for any course for which he/she has been allowed.

Grade Point Average / Cumulative Grade Point Average

Grade Point Average (GPA) for any semester and Cumulative Grade Point Average (CGPA) for more than one semester shall be calculated as under:

Indulgence in any of the above acts, can result in appropriate disciplinary action which may be restriction or expulsion from University for specified period or for good or fines up to the maximum of Rs: 5000/- (Five Thousand). In this regard the Vice Chancellor is the sole and final authority.

Award of Degree

Bachelor degree will be awarded to the candidate who qualifies all the requirements of the programme with aggregate CGPA 2.5.

Project / Thesis work in the fourth year of study (Bachelor Programmes)

- (i) The students who secure less than 3(three) CGPA up to sixth semester can take Project of three credit hours in eight semester in lieu of one course.
- (ii) The students who secure 3 (three) or more CGPA up to sixth semester will be allowed to take thesis of six credit hours, one course from seventh and other from eighth semester will be droped in lieu of 6 credit hours thesis

All students of the Federal Urdu University of Arts, Sciences & Technology shall conform to the Rules and Regulation of the University and shall be under overall disciplinary control of the Vice Chancellor.

- (a) Every student must carry his/her identity card which shall be open to examination and may be demanded at the time of entrance to every function. No student will be admitted to the University unless he/she is in the possession of the University Identity Card.
- (b) No student is eligible to sit for the University Examination unless he/she has at least 75% attendance at the courses of relevant programme.
- (c) A student will have committed a breach of discipline or an act of general misconduct if the student:
- 1. Behaves in a manner which is detrimental to the interests and good repute of the University.
- 2. Harasses any person on any grounds, including ethnicity, gender, sexual preference or religious or political belief.
- 3. Engages in threatening /pressurising Faculty Members and/or Officers of the University inside or outside the university premises.
- 4. Engages in creating disturbances in the Class Rooms/Laboratories.
- 5. Engages in creating law and order situation in the University premises.
- 6. Will fully, recklessly or negligently engages in conduct which causes, or may cause bodily injury to any person.
- 7. Engages in improper use of any University facilities or equipment.
- 8. Engages in any other conduct, whether within or outside the precincts of the University, that may be prejudicial to the good order and discipline of the University or is likely to bring the University into disrepute.
- 9. Fails by the required date, or within the required period, to pay any fine or observe any penalty imposed by this Regulation.
- 10. Students are not allowed to make gathering, shouting, salogans and groups clashing in the university premises, such activities are prohibited.
- 11. Students are not allowed to the stairs for sitting purpose in campus blocks, it is prohibited.
- 12. Without permission visitor will not be allowed untill he/she gives his/her NIC to security uard and take entry pass. After that visitor will collect his NIC from the same security person.
